- Validation, Accounting Record and Storage in data bases of electronic invoices (CFDI), files PDF and XML, thus assisting the user in accelerating the IVA recovery process in a timely manner.

...PROCESSES AUTOMATED BY THE SYSTEM



- Payments of Estimated ISR Tax.
- Fixed Asset accounting and tax depreciation.
- Annual ISR Tax Return.
- Schedule of annual adjustment due to inflation, updating of tax losses, and other work papers for purposes of the annual ISR tax return.
- Annual projection of the ISR and the profit coefficient at any moment desired by the user.

- Generate the XML files to send Chart of accounts, Balance and Vouchers to the SAT Tax Mailbox.

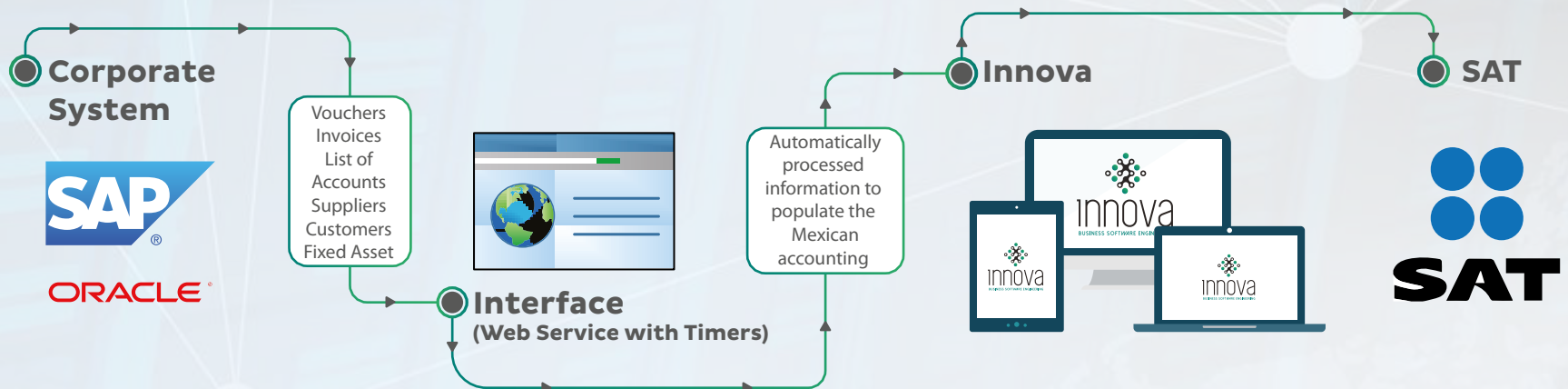

1 DATA ENTERING IN THE CORPORATE SYSTEM:



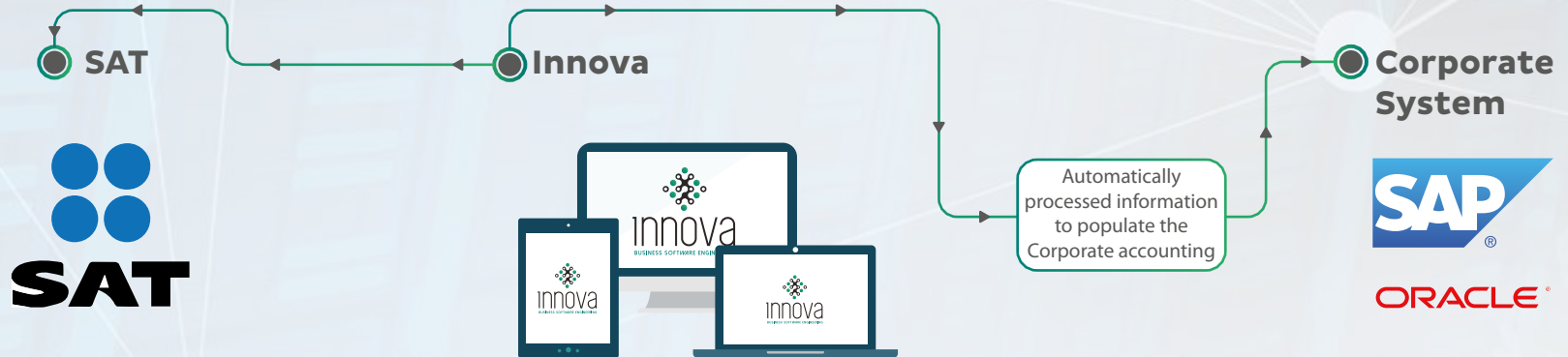

● 2 DATA ENTERING IN INNOVA:

We recommend this option due to the fact that Mexican accounting is more detailed than U.S. accounting, meaning that the interface does not entail additional work for purposes of reclassifying entries.

Also, the Purchases and Budgets module allows the user to add greater functionality to the System by improving the Administrative controls, as is the case with the 3Way Match and the budgetary control of the committed expenditure.

ADDITIONAL FUNCTIONALITY

The Purchases, Warehouse and Budgets modules jointly allow the user to carry out the following:

- Automation of the account payable by validating the amount of the Purchase Order against the amount of the receipts and the invoice. (3 Way match pursuant to the SOX Law).
- Control of the expense at the moment of generating the requisition by validating the exercised and committed budget.
- Itemized report of expenses by department with the option to consolidate by cost center.
